Synopsis:

On 3/18/22 at 1948 hours, patrols responded to 4 Field of Dreams Drive to attempt to locate Daniel Dolan, who had an active affidavit warrant for Domestic - Vandalism/Malicious Injury to Property (RIGL 11-44-1/A) and Domestic Disorderly Conduct (RIGL 11-45-1/A) issued by this department.

Main Narrative:

Upon arrival, we approached the residence and were met in the driveway by Daniel's wife, . As we began speaking with ., I overheard a male's voice coming from the area just east of the driveway near the chicken coup. The male, who was positively identified as Daniel, approached Off. Brodeur, and he stated, "You guys are taking me?" Daniel showed little emotion and did not act surprised in the least bit while speaking with him about being placed into custody. At 2037 hours, Daniel was placed into custody without incident and searched by Off. Brodeur.

As Off. Brodeur transported Daniel to HQ to be processed, Sgt. Guglielmo and I spoke with inside the residence. Although . was crying and visibly emotional in regards to Daniel being taken into custody, it was clear that a weight had been lifted off her shoulders. advised that the relationship has been strained as they have have gotten into arguments several times a week. stated that there is a lot going in in regards to his other open case and her current health situation. said on top of their own issues, raising 4 children has made things even more difficult and stressful at times. stated that most mornings Daniel wakes up angry and she spends most of the day in fear of what he may possibly say or do to her and the children. advised she hopes that Daniel being arrested will be a step in the right direction in getting the services he needs in regards to anger management.

While speaking with ., I requested she provide a written statement describing the events from earlier in the morning. was hesitant and advised she would like to think about it. I advised that I would reach out to her the following day, 3/19/22, when I returned to work and check in with her.

Damaged Items:

The middle of the front windshield was cracked and spidered towards the top and bottom.

DV/SA Form:

did not complete a written statement at this time, however, she did fill out a DV/SA form. Prior to leaving, was given both the Victims Rights and Safety Plan pamphlets.

Arrest/Booking:

At 2037 hours, Daniel was placed into custody (double-locked, behind the back) and searched. Off. Brodeur then escorted Daniel to the rear seat of his patrol vehicle (#74) and secured him in the rear cage. At 2041 hours, Daniel was transported to HQ without incident. Upon arrival to HQ, Daniel was escorted to the cell block where Off. Mensah completed an A&B report, fingerprints, and photographs. At 2144 hours, Daniel was afforded

the opportunity to place a phone call, which he did at this time.

Upon completion of the booking process, Daniel was secured in cell A1 at 2157 hours.

DCYF:

Earlier in the shift, at 1800 hours, I contacted DCYF (1-800-RI-CHILD) and spoke with Case Worker . I informed Case Worker of the incident and later faxed a copy of the report to her.

Conclusion:

Daniel was charged with Domestic - Vandalism/Malicious Injury to Property (RIGL 11-44-1/A) and Domestic Disorderly Conduct (RIGL 11-45-1/A).

On 3/19/22 at 1022 hours, after being arraigned by the Bail Commissioner Daniel was transported to Men's Intake by Off. Green.

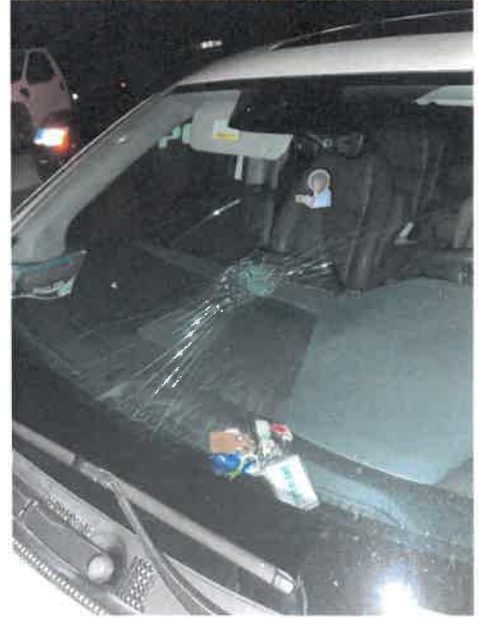
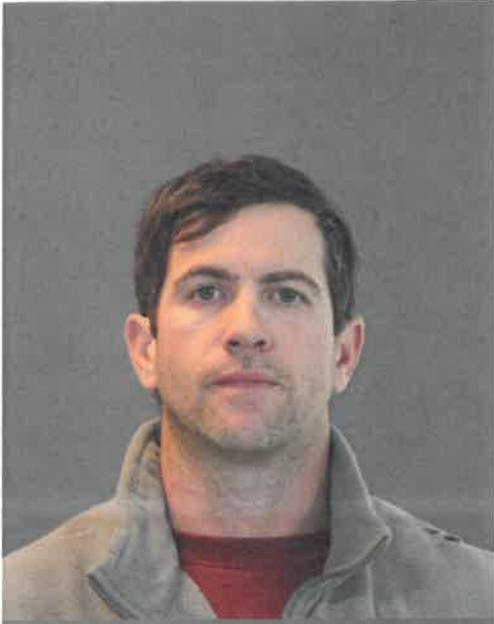
Additional Information:
