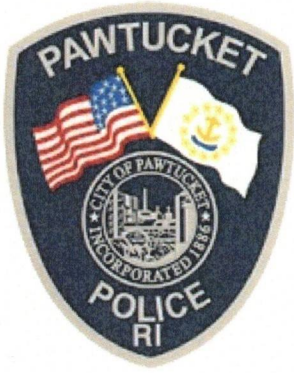
President Moran,

Good Afternoon! The Pawtucket Police Department will be utilizing body worn cameras in the near future. Pawtucket was one of the first departments to begin the process with the State of Rhode Island to seek grant funding for body worn cameras. The department has been awarded a five year grant for the program but are awaiting the distribution of funds. At this time, the funding schedule has not been finalized by the state but once the funds have been distributed the program will commence shortly thereafter. I will keep you apprised of any updates.

The request to switch from number boards to name badges is a contractual issue. I will reach out to representatives from the union to see if there is a willingness. I will keep you updated once I have a response.
