Probable Cause

On 9/2/2023 at approximately 2102 hours, I was conducting a stationary traffic post at the intersection of Main St. and Sandy Bottom Rd. in marked patrol vehicle 2436, when I heard tires screech and a loud engine revving. I then looked towards the intersection and observed a dark colored pickup truck turning left onto Main St. from Sandy bottom Rd. at a high rate of speed causing the vehicle's back end to sway to the right and almost going off the road. The vehicle then over corrected and crossed over the double yellow line in order to begin traveling west on Main St.(probable cause to arrest continued in main narrative)

Narrative Continued:

I immediately activated my lights and sirens as the vehicle had turned onto Main St. By the time I pulled out from the parking lot of 1037 Main St., the truck was almost out of view and was still traveling west on Main St., at a high rate of speed that I estimated to be over 50 MPH. It should be noted, there was moderate traffic in the area at the time of the incident. I then caught up to the vehicle described as a grey Chevrolet Silverado bearing RI CM 127657, which had pulled over to the side of the road just west of the intersection of Main St. and South Main St. I approached the driver's side of the vehicle and asked the operator for his license, registration and proof of insurance which he was able to provide. Before getting his license the operator then stated, "you know who I am" and I had to advise him that I did not know who he was. I then identified the operator as Daniel Dolan VIA RI OLN . I advised Daniel the reason I stopped him was for driving erratically and laned roadway violations. It should be noted two passengers were inside the vehicle as well identified as Richard Dobbs and Matthew Houck.

I asked Daniel why he was driving his vehicle erratically to which he stated "I was just trying to get home." I then asked Daniel if he had been drinking to which he stated "No". While speaking with Daniel I noted the odor associated with the consumption of alcoholic beverages emanating from inside the vehicle. Daniel also had bloodshot, watery eyes and his speech was slow and slurred. At this time, Lt. Cloutier, Sgt. Jacavone and Off. Fernandez arrived on scene.

Dispatch conducted MVD/NCIC checks of the operator and the vehicle. MVD checks of the operator showed him to have an active license. NCIC checks of the operator were negative. MVD checks of the vehicle came back active to a 2022 Chevrolet Silverado, color grey; NCIC checks of the vehicle were negative. At this time I asked Daniel if he would submit to a Standardized Field Sobriety Test which he stated "Yes" he would.

Standardized Field Sobriety Testing:

While getting out of his vehicle, Daniel began to stumble and had to use the vehicle to support himself with his left hand. I then escorted Daniel to the side of his vehicle where there was an open parking lot. I started with phase one, the Horizontal Gaze Nystagmus Test and I positioned Daniel on a flat section of the parking lot facing away from any emergency lights. In addition all forward facing strobes were turned off. I instructed Daniel to stand with his feet together and hands down by his sides. While holding his hands by his sides, Daniel began to clench his fist and became aggravated stating he was an FTO and knew how to conduct this test. At this time, I detected the strong odor associated with the consumption of alcoholic beverages emanating from Daniel's breath. I asked Daniel if he had any injuries or difficulty seeing, which he stated, "No." I then raised my right index finger approximately 12-15 inches away from his face and slightly above eye level. I instructed Daniel to follow the tip of my finger with his eyes only, without moving his head. I asked Daniel if he understood my instructions, which he stated, "Yes." I began the test and observed his pupils appeared to be of equal size and that both eyes tracked together. I noted lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes and the onset of nystagmus prior to forty-five degrees in both eyes. Checks for vertical nystagmus were negative. During the test, I had to remind Daniel twice to keep his head still and to follow my finger with his eyes and his eyes only, due to him following my finger with his whole head. I observed four clues in the Horizontal Gaze Nystagmus test.

The next phase of the test was the Walk and Turn test. I positioned Daniel on a flat and straight section of the parking lot that was free from any debris or defects that could interfere with the test. I instructed Daniel to stand with his right foot in front of his left foot, in a heel to toe fashion, with his hands down by his sides, until I told him to start the test. I then explained to Daniel that when told to begin the test, I wanted him to take nine heel to toe steps in a straight line, while looking down at his feet, counting each step out loud, and keeping his hands down by his sides. On the ninth step I instructed Daniel to keep his lead foot in contact with the ground, while taking a series of small steps with the other foot to turn around, then take nine heel to toe steps back in the same manner as before. During the instruction phase Daniel broke his stance two times, in which Sgt. Jacavone had to catch him from falling over and I had to remind Daniel to not move from that position until told to do so. I then demonstrated the test to Daniel and asked if he had any injuries that would prohibit him from taking the test, which he stated "No." I advised Daniel once he begins the test that he is not to stop until the test is completed. Daniel stated he understood and I advised him to begin. During the first phase of the test Daniel missed heel to toe on steps three and four. Daniel also used his arms for balance by raising them above 12 inches from his sides several times. Daniel then made a proper turn and continued with the second phase of the test. During the second phase of the test Daniel missed heel to toe on steps five and seven. I observed three clues in the Walk and Turn test.

I then advised Daniel the next phase of the test would be the One Leg Stand test. I instructed Daniel to stand with his feet together and hands down by his sides, until I requested him to begin the test. I instructed Daniel when told to begin the test he would raise either leg of his choosing approximately six inches off the ground, with the bottom of the raised foot parallel to the ground, while keeping both knees straight. I instructed Daniel to look down at his raised foot, keep his hands down by his sides, and count in a one-thousand format until told to stop. I advised Daniel if he is to drop his foot to the ground at any time he is to pick it back up and continue the test from where he left off. I asked Daniel if he understood my directions which he stated "Yes." I asked Daniel if he had any injuries that would prohibit him from taking this test, which he stated, "No." I instructed Daniel to begin the test, which he did by raising his right leg approximately 3 inches off the ground before immediately dropping his leg to the ground. I advised Daniel to raise his foot and to continue the test. I also observed Daniel using his arms for balance by raising them above 12 inches from his sides. Daniel again raised his right foot three more times but was unable to hold his leg up on each attempt and began to fall over. On the last attempt to raise his right leg, Lt. Cloutier and Sgt. Jacavone had to catch Daniel from falling over so he would not fall to the ground. For Daniel's safety I ended the test at the elapsed time of twenty seconds. I observed three clues in the one leg stand.

Arrest:

At 2112 hours, I advised Daniel he was under arrest for suspicion of DUI. Daniel was handcuffed (double locked), searched and secured in the back of my patrol vehicle. It should be noted while placing Daniel into custody he stated "you guys are doing a great thing and should feel really proud of yourselves". Daniel was read his Rights For Use At Scene from a pre-printed card at 2113 hours. This was witnessed by Sgt. Jacavone. I then began transport of Daniel to CPD HQ's at 2114 hours.

Video Recording:

At 2116 hours, I arrived at HQ's with Daniel where he was escorted to the A&B room and a video recording was started. A request was later made to the department BCI evidence custodian for the recording of the DUI room to be retained as evidence.

Implied Consent Notice (Over 18):

At 2120 hours, I finished reading Daniel his Implied Consent Notice (Over 18) from a pre-printed form. Daniel was advised he had the right to be examined by a physician of his own choosing and at his own expense. He was offered the use of the telephone to arrange for an additional test, notify a family member, and/or contact and attorney. This was witnessed by Sgt. MacCoy. It should be noted while reading Daniel the Implied Consent Notice, he made comments stating "beat me cocksucker", and for me to "shut the fuck up." Daniel was also told to sit down several times as he continued to stand up and advance towards me while clenching his fist as if prepared to fight. Daniel was advised to sit down after each of his attempts to stand up.

Telephone:

At 2122 hours, Daniel was offered the use of the telephone to place a private and confidential phone call several times to which he declined.

Breathalyzer Testing:

At 2123 hours, I requested Daniel submit to a chemical test to which he refused to answer.

Booking:

At 2123 hours, Daniel was secured in cell A1 due to him being uncooperative and aggressive by yelling "get the fuck out of my cell", "you're a pussy" and "shut the fuck up." Daniel later completed his A&B report where he was fingerprinted and photographed by Off. Hill at 0140 hours.

Summons/Citations:

Daniel was issued a 3rd District Court Summons for DUI/Drug/Alcohol/1st Offense-B.A.C Unknown and Reckless Driving with a pending court date of 9/13/2023. Daniel was also issued citation # 23201500860 for Refusal to Submit to Chemical Test and Laned Roadway Violations with a pending RITT court date of 9/12/2023.

Tow/Inventory:

Daniel's brother identified as Michael Dolan arrived on scene at 2201 hours to take custody of the vehicle. Due to both Richard and Matthew also appearing to be intoxicated, Off. Callinan transported both parties to Matthew's residence at 2153 hours.

Additional Information:

On 9/3/2023 at 0800 hours, I was advised that while Daniel was secured in cell A1 the night prior at 2126 hours, Daniel made a comment stating "next time I'm shooting" and "next time I'm killing you faggots" while I was still in the A&B room. I did not hear the comment being made at that time however, a request was made to the department BCI evidence custodian for the recording of cell A1 to be retained as evidence. I later reviewed the video and audio recording which confirmed the statements made by Daniel. Due to this comment, Daniel is also being charged with Threats to Public Officials.

Daniel was released into the custody of his brother Michael Dolan at 0148 hours on 9/3/2023.

On 09/03/2023 at approximately 0120 hours I, along with Sgt. Casey and Ofc. Callinan, removed Daniel Dolan from Cell #A1 for processing. While being processed Daniel made several threatening comments toward us. He repeatedly told Sgt. Casey that he would "smash" him and continuously acted like he wanted to fight. It is also worth noting that while I finger printed Daniel, I could smell alcohol on his breath and I noticed that his eyes were bloodshot and watery.

After I finished processing Daniel, we waited with him until he got a ride home. During this time, Daniel made a comment about the last time Coventry Police Officers had to go to his house. He stated that we walked right up to the front door like rookies, and that it would have been easy to pick us off one by one. He went on to say that he didn't because he was feeding his chickens at the time.

At one point Daniel asked me, "do you know who I am?", and I told him that I didn't. He went on to inform me that he was the off-duty Pawtucket police officer who shot two kids that were speeding on the highway. I asked him, "did you shoot them, or shoot at them?", and he replied that he hit one of them in the arm.

Daniel was released and picked up by his brother, Michael Dolan.

On 09/03/23 at 0120 hours, Sgt. Casey, Ofc. Hill and I removed Daniel Dolan from cell #A1 for processing. After we finished finger printing and photographing Daniel, we had him sit on the bench in the A&B room until his ride arrived. Daniel said that when Coventry Officers had arrived at his house

during a past incident he said, "You guys showed up seven cars deep and walked in like a bunch of rookies. I should've picked [shot] all of you off one by one". Then followed by "I could've picked all of you off one by one, but I was feeding my chickens." He was released and picked up by his brother, Michael Dolan, shortly after.

On 09/02/2023 at 2104 hours, Lt Cloutier, Off Fernandez and I responded to assist Off Mason with a motor vehicle stop near the intersection of Main St and South Main St. Off Mason had called out that a black pick-up truck had "taken off at a high rate of speed" westbound on Main St near Sandy Bottom Road, and he had caught up to it when it stopped in front of 1175 Main St. The vehicle was confirmed to be grey Chevrolet bearing RI CM 127657.

Upon my arrival, Off Mason informed me he had identified the operator as Daniel Dolan and he appeared highly intoxicated. Daniel is a suspended Pawtucket Police Officer who the department has had numerous previous contacts with. Off Mason briefly explained that he had been at a stationary traffic post at the intersection of Main St and Sandy Bottom Rd, when he heard an "engine revving" and "tires screeching" and looked up and observed the suspect vehicle turn left (west) onto Main St from Sandy Bottom Rd at a high rate of speed. He said the suspect vehicle "fish tailed" as it entered Main St, swerving from side to side, nearly losing control, and crossing the double yellow line, before correcting itself and "taking off" westbound.

There was also a white male passenger the front seat, identified as Richard Dobbs, and a white male passenger in the back seat, behind the driver's seat, identified as Matthew Houck. They also appeared intoxicated at the time of the stop.

Off Mason then returned to the driver's side of the vehicle, and began a DUI investigation. He asked Daniel if he would submit to a battery of Standardized Field Sobriety tests, to which he said he would. He asked Daniel to step out of the vehicle, to which he complied. I noted that Daniel's speech was slow and slurred as he spoke to Off Mason and his eyes were bloodshot and watery. I noted that Daniel stumbled as he exited the vehicle, and swayed from side to side appearing to have trouble keeping his balance as he walked to the rear of the vehicle, and then into a small driveway near 1175 Main St. Off Mason and I had to order him to stop walking and remain standing in the driveway. Daniel then blurted out, "I used to be an FTO."

Prior to Off Mason beginning the SFSTs, I had conducted a pat-down of Daniel for safety purposes. He then turned to me and said, "Did you find it? Did you find anything you were looking for?" I again noted his speech was slow and slurred, and I detected the odor associated with the consumption of alcoholic beverages on his breath. As Off Mason attempted to start the battery of field sobriety tests with the Horizontal Gaze Nystagmus, we noted Daniel was clenching his fists and staring at Off Mason. Lt Cloutier ordered him to unclench his fists, and he refused, stating, "I'll never stop clenching them! I'll never stop clenching them! That's what I do!" I again ordered Daniel to stop clenching his fists, but he still refused to comply. I warned Daniel to follow Off Mason's SFST directions, and he continued with the battery of tests.

Off Callinan responded to the scene to provide transportation for Matthew Houck and Richard Dobbs back to Matthew's residence at . Richard was picked up first and I remained on scene with Matthew. While speaking with Matthew, he told me he had met up with Daniel earlier that evening at Dragon Palace, where Daniel had already "been drinking two Scorpion bowls". Matthew said he thought Daniel was already intoxicated when he first arrived, but he still insisted on driving when they left. He said he and Richard had yelled at Daniel to "stop and pull over" when they noticed he was speeding away with Off Mason's vehicle emergency sirens sounding and lights flashing behind them, but he refused to stop. Matthew stated he had to force Daniel to stop; "I saw you guys behind us and told him to stop. I finally had to grab him by the neck to make him stop the truck."
