 - A. Article III, Chapter 7 Planning Commission Membership Adding Alternative (2) Alternate Members

- 1. Under Section 3.07 of the Charter, the planning commission consists of 7 members as appointed by the Mayor. The Charter Commission is asked to consider adding (2) alternate members to the Commission as appointed by the Mayor for a term consistent with the full voting members who will take the seat of a full voting member when they are not available or absent from the planning commission meeting.
- 2. Proposed Language:

Current Language: The city planning commission shall consist of seven (7) voting members appointed by the mayor. On the first Monday of January in 1954, or as soon as may be thereafter, five members shall be appointed to serve until the first Monday of January, one, two, three, four, and five years thereafter, respectively. On the first Monday of January in 2023, the mayor shall appoint two (2) additional members to the city planning commission such that the city planning commission shall have seven (7) members. On the first Monday of January in each succeeding year, or as soon as may be thereafter, there shall be appointed one member of said board to succeed each member of said board whose term is expiring, and to hold office until the first Monday of January five years thereafter.

Proposed Language: The city planning commission shall consist of seven (7) voting members and (2) two alternative members appointed by the mayor to a term of (5) five years. On the first Monday of January in each year, or as soon as may be thereafter, there shall be appointed one member of said board to succeed each member of said board whose term is expiring, and to hold office until the first Monday of January five years thereafter so that the terms of each member and alternate are staggered to allow for an appointment of a member in January of each year.

Alternative members shall be allowed to participate in any matter before the commission, but shall only be allowed to vote on any matter when taking the place of one of the seven member(s) of the commission who may not be present at the mee
